THE ALAN TURING INSTITUTE

There has never been a more significant time to work in data science and AI. There is recognition of the importance of these technologies to our economic and social future: the so-called fourth industrial revolution. The technical challenge of keeping our data secure and private has grown in its urgency and importance. At the same time, voices from academia, industry, and government are coming together to debate how these technologies should be governed and managed.

The Alan Turing Institute, as the UK's national institute for data science and artificial intelligence, plays an important part in driving forward advances in these technologies in order to change the world for the better.

The Institute is named in honour of Alan Turing, whose pioneering work in theoretical and applied mathematics, engineering and computing is considered to have laid the foundations for modern-day data science and artificial intelligence. The Institute's goals are to undertake world-class research, apply its research to real-world problems, driving economic impact and societal good, lead the training of a new generation of scientists, and shape the public conversation around data and algorithms.

After launching in 2015 with government funding from EPSRC and five founding universities, the Institute has grown an extensive network of university partners from across the UK and launched a number of major partnerships with industry, public and third sector. Today it is home to more than 500 researchers, a rapidly growing team of in house research software engineers and data scientists and a business team.

BACKGROUND

Programme Management

The Alan Turing Institute has ten Programmes of scientific research in key areas of AI and data science, each led by a Programme Director. There are also a small number of significant programmes of activity which sit across several research Programmes.

This role sits within the Institute's Programme Management directorate, which is responsible for the management and delivery of these programmes in support of the senior academic Programme Directors and Principal Investigators. The team oversees millions of pounds of data science and AI research, training and knowledge exchange programme initiatives in these programmes, ensuring they are managed to business requirements, specification, time and budget.

There are a number of Programme and Research Project Managers within the team, usually focussed on one research Programme or programme of activity, but who may provide programme and project management capabilities and support to other projects or activities from time to time as required. Programme managers and Research Project Managers are not permanently attached to programmes and may be moved to other research programmes in-line with business needs, and may have the opportunity to support other programmes, both ad-hoc or more formally.

At the end of 2018, the Alan Turing Institute was awarded a five-year £38.8 million research programme through UKRI's [Strategic Priorities Fund](#). AI for Science and Government (ASG) is delivered in partnership with the Engineering and Physical Sciences Research Council (EPSRC) and in collaboration with a number of other research councils.

The research activities will support UK priority areas which are nested within existing Institute [programmes](#) and aims to deploy AI and data science through six themes, as well through cross-theme activity:

Themes

- **Digital Twins: Urban Analytics** underpinning the planning system;
- **Digital Twins: Complex Engineering Systems** in industry;
- **Health**: revolutionising health services through precision medicine;
- **Criminal Justice System**, laying foundations for AI in government departments and agencies;
- **AI for Science**: delivering AI into national labs;
- **Tools, Practices and Systems**, bringing best practice into domain areas.

Cross theme projects

- **Shock and resilience** – Measuring policy impact in the COVID-19 crisis and building resilience against future shocks
- **Ecosystem of Digital Twins** – Brining together multidisciplinary expertise in urban analytics, complex systems engineering and economics
- **Environment and sustainability** – Using data science and AI to tackle environmental and climate challenges

ROLE PURPOSE

A Research Project Manager at the Turing coordinates the implementation and delivery of advanced data science, AI and modelling research projects, and research engineering innovations in data, software and collaborative practices. The Alan Turing Institute is looking to appoint a Research Project Manager to coordinate and support work across the AI for Science and Government programme. The Research Project Manager (ASG) will play a central role in assisting with the overall facilitation of delivery of projects across the ASG programme.

The post holder will work within the ASG programme team comprising the ASG Programme Chair, ASG Programme Director, Associate Director and the ASG Programme Manager, to ensure the delivery of the programme outputs and the achievement of the outcomes. This team is supported by a dedicated Finance Business Partner.

The post holder will work with the programme's scientific leadership, project leads, academic researchers and the other Research Project Managers who are responsible for managing ASG theme or cross-theme research, to coordinate each research project from concept to implementation; this will involve understanding the resource requirements for each project, drawing up detailed financial plans, coordinating funding applications, negotiating funding or collaboration contracts, agreeing on clear milestones for each project, ensuring that the deliverables are completed on schedule, as well as providing regular updates to the Institute's leadership on the progress of each project.

The role will also involve planning, organising and communicating some of the activities generated by those projects. Working closely with theme Research Project Managers, the Research Project Manager (ASG) will help to ensure activities are coordinated and consistent across all themes. This role will also assist the ASG Programme Manager in managing the interactions with the key programme stakeholders that sit on the various governance group, in particular the funder, EPSRC.

The role currently reports to the ASG Programme Manager.

DUTIES AND AREAS OF RESPONSIBILITY

Research project management and delivery

- Coordinate and oversee the delivery of research projects. This will involve:
 - Working with the theme Project Managers and research teams to ensure resource requirements for each project, are captured along with clear milestones for each project, and to ensure that any deliverables are completed on schedule.
 - Working with the theme Project Managers and Turing's finance team to combine project budgets and analyse monthly financial statements, reporting to the Programme Manager

- Working with the Turing's legal and governance teams to ensure that relevant contractual and legal agreements and processes are in place and followed, including for data sharing and ethical considerations.
- Working alongside the communications team to disseminate information about the programme and findings of projects in collaboration with theme Research Project Managers where appropriate.
- Coordinate some of the programme's events, training, and knowledge exchange initiatives. This will involve:
 - Working alongside researchers and the programme's leadership to identify a suitable venue for each initiative, to shape the agenda, to create the guest list, to publicise the initiative, and to ensure that meeting minutes are taken and distributed.
- Maintain up-to-date records that enable effective monitoring, control and evaluation of the programme's research initiatives.
- Coordinate the creation of the quarterly ASG newsletter
- Produce and collate regular reports on activity to external partners and funders.

Programme operations and resources management

- With the Programme Manager, coordinate the delivery of strong programme governance. This will involve managing the ASG programme's Management Board and External Advisory Board, including developing the agendas with the Programme Chair and Director, drafting or collating relevant board papers, minuting meetings and ensuring records of all key decisions and discussions. It may also include developing, writing, and editing reports and presentations for the Institute's senior leaders, Board of Trustees, and funders, which outline the programme's progress and initiatives
- Working with the HR team as appropriate, organise the recruitment of additional researchers or business team staff. This may involve writing job advertisements, organising interview panels, and overseeing the onboarding process for new hires.
- Provide day-to-day support to the ASG programme team as required

Please note that job descriptions cannot be exhaustive, and the post-holder may be required to undertake other duties, which are broadly in line with the above key responsibilities.
