Background

The Nepal Health Sector Support Programme 3 (NHSSP 3) had begun in March 2017 as the technical assistance (TA) component of FCDO's Nepal Health Sector Programme 3 (NHSP3), and included two TA components, the General Health Technical Assistance (GHTA) to support the federal MoHP to deliver its Health Sector Strategy 2015-2022; and the Retrofitting and Health Infrastructure TA (RHITA) to MoHP and Department of Urban Development and Building Construction (DUDBC) to support the retrofitting and rehabilitation of two priority hospitals in earthquake affected areas. A no-cost extension for the programme was confirmed recently, to provide support for completion of retrofitting of the two public hospitals, and to enable essential components of health reform in the context of federalism. The no-cost extension is referred to as RHITA+ reflecting this dual purpose and will be delivered by Options.

The health systems strengthening component of RHITA+ will mainly have a sub-national focus and provide support for the early implementation phase of the new Nepal Health Sector Strategic Plan, 2022-2030. The federal constitution mandates local governments to deliver the Basic Health Services package (BHS) and provincial governments are now responsible for most of the referral services. Support is required to enable these subnational governments to strengthen their capacity for governance and accountability, and to provide quality health services which everyone can access without financial burden.

Main purpose of the Job

The M&E and Information Systems Advisor will primarily support the RHITA+ federal level and provincial teams, and provide TA to relevant government counterparts to strengthen the use of evidence. The key objective of this role is to build evidence and support internal learning for better programme delivery, as well as to share learning with key counterparts and other external audiences. The job-holder will contribute to the planning of monitoring, evaluation and learning activities to ensure that the objectives of the programme are achieved

Main duties

Technical delivery responsibilities

- Proactively support government and build capacities of officials at each level of governance to effectively use the data systems for planning and decision-making purposes.
- Support the implementation of data systems, by identifying the capacity needs, supporting any orientation and training of stakeholders to adopt the improved systems on a regular basis for programme and policy planning.
- Oversee the support to the development and roll-out of technology based solutions (e.g. digitised MSS, electronic health record system, BHCS, QIMIS, and other web-based data management systems) at federal, provincial and local level.

- Provide oversight to the development and tracking of indicators on the RHITA+
 Logframe, and support the development of any monitoring frameworks and systems
 needed for the meeting the Logframe requirements (e.g. Learning Lab monitoring, BHCS
 monitoring, OCMC monitoring, CEONC functionality monitoring, etc.)
- Conduct and oversee any evaluations, operational research studies, equity analysis, etc.
 This may include support to the design of the studies, tool development, training, data gathering, analysis, interpretation and reporting.
- Support any activities to develop an understanding of GoN budget and expenditure trends and participate in subsequent discussions and planning at all governance levels based on findings.

Cross-team responsibilities

- Provide substantive technical inputs to identify gaps in evidence on SMNH and FP/SRH issues, and help build such evidence that supports piloting any high impact packages these services in selected areas and with specific population groups; leading on operational research and any evaluations needed to improve services to achieve LNOB goals.
- Support policy development and strengthening at the MoHP level from a D4D perspective, through active engagement with stakeholders within the ministry and across the relevant divisions of the DoHS.
- Provide technical inputs to other thematic areas, and support cross-team and crosssphere co-ordination and collaboration to enable effective alignment at federal, provincial, and palika level.
- Support and provide inputs to monitor and build evidence on GESI/LNOB programmes and facilitate evidence based decision-making on these issues.
- Collaborate with other NHSSP thematic areas to develop an understanding of GoN budget and expenditure trends in the respective technical areas and participate in subsequent discussions and planning at all governance levels based on findings.

Management responsibilities

- Support analysis and writing any technical outputs and payment or non-payment deliverables as assigned and collaborate with the other members of the RHITA+ team as required in a timely and proactive manner.
- Identify, monitor and report any risks arising to the programme delivery; and under the leadership of the RHITA+ Team Lead contribute to managing and addressing risks.

One-team approach, Collaborations and Relationships

- Adopt a "one team approach" to the delivery of the programme, consistently work towards achieving the cross cutting objectives of building the resilience and improving the equity and quality of the Nepal health system while Leaving No-One Behind.
- Work collaboratively with all RHITA+ members at federal and sub-national level to ensure consistency and quality of the programme delivery.
- Build and manage positive and productive relationships with MoHP, DoHS and provincial government counterparts an on-going basis, and apply supreme diplomacy, influencing and consensus-building skills to build alliances with a range of stakeholders, external development partners and networks.
