Main purpose of job

The role of Technical Advisor HSS is to provide technical support in to programmes that strengthen health systems in low and middle income countries (LMICs). The post-holder will be able to appreciate the complexities of health systems including the political context in which they function, provide specific support for one or more of the health systems build blocks, and be able to critically appraise data and evidence on Health Systems and RMNCAH.

Theis post can be based in any of the following countries: UK, Kenya, Nigeria, Malawi, Tanzania, Nepal or Bangladesh and will involve is London-based with regular overseas travel, as agreed with the line manager. Applicants must be eligible to work any of the above countries, in the UK and be fluent in spoken and written English. Ability to work in French is desirable.

Main duties

Technical Assistance to Programmes

- As part of the core Technical Team, provide technical support on HSS and quality assurance for technical inputs across Options' Programmes in your area of expertise
- Undertake technical assistance assignments that seek to strengthen health systems through ongoing inputs to long term programmes and one-off assignments
- Provide technical support to national systems and capacity development to country stakeholders including programme staff, government officials and civil society organisations



- Undertake technical assistance tasks under the guidance of a senior member of the Technical Department, as required
- Support programme staff to appraise and use global and local data and evidence to strengthen the quality of programme delivery
- Enable learning from programmes and technical exchange between programme staff
